Guidelines and Procedures:

1. Entrants should submit their entries at the nearest LBC branch. The design state starts from September 1, 2024 and the deadline for submission of entries is on December 31, 2024.
2. All requirements and design entry should be sealed in A3 padded pouch or bubble mailer.
3. Entrants must present the following:
 - School ID
 - Photocopy of ArchiNEXT entry form
 - LBC Free Shipping Letter
4. A copy of Official Receipts (Reprinted OR) shall be issued to entrants. This will serve as proof that they have already sent their entries.
5. LBC accepting Associate must ensure that the entries from the contestants are sealed and labeled properly. (Name of the Entrants).
