Guidelines and Procedures:

1. Students/entrants may visit the nearest LBC outlet on their area to send their entries. Deadline of submission is December 31, 2021.
2. All entries are in A3 size, sealed in smaller or a maximum of A3 sized envelope.
3. Students/ entrants must present the following:
 - School ID (should currently be enrolled as 3rd or 4th year)
 - Photocopy of the ArchiNEXT Entry Form
4. All LBC Branches will process the entries as Day 1 shipment using our published rate through **CAMS** for Charge basis. Make sure that the entries are unfolded, free from stains.
5. A copy of Official Receipts (**Reprinted OR**) shall be issued to Contestants. This will serve as proof that they have already sent their entries.
6. LBC accepting Associate must ensure that the entries from the contestants are sealed and labeled properly. (Name of the Contestant).


